AUDIENCE PARTICIPATION

Maire & Meara Headwaters Trails Alliance

Meara (Executive Director) and Maire (Finance Development) from Headwaters Trails Alliance presented the board with updates on Stand Grand. Meara shared updates on the ambassador program and trail work. She said the Annual Report will be out next month and sent to Gaylene to share with the board.

This year HTA held USFS SRT training. HTA is working on ways to share the same messaging about Stand Grand (Leave No Trace principles) throughout the county and keeping

housing Stand Grand and wondering if HTA is the best fit to house Stand Grand and would like to see the information on the GCCTB website to get more viewership and engagement.

Gaylene mentioned that there is a bit of confusion on Stand Grand and "Leave No Trace" wording. Maire said that Stand Grand is part of "Leave No Trace," but the name Stand Grand was chosen to fit in with Grand County.

Carrie mentioned there is a place for the board to put Stand Grand information on the website. Maire wanted to know if Gaylene could attend the quarterly communications meeting. Gaylene said she would be able to attend.

He also reported that the County asked us about a law coming out from the STR. The bill will go to the state legislator in January and is supported by the governor of Colorado.

There was discussion on what we could do to oppose this bill.

Cheryl said that CO Ski Country - CHLA (Colorado Hotel and Lodging) and larger organizations are looking at trying to activate people on this bill.
