## Katy Introduced Grand Beginnings & Current Issues

- 1. Not enough capacity for care for children in Grand County (mentioned that this is also a national and state issue).
- 2. Childcare cost is an issue for local families.
- 3. It is expensive to run a childcare facility. The prices charged do not meet the costs of running a childcare facility.
- 4. Often families leave Grand County or do not move to the county due to lack of childcare.

# **BOCC Meeting 12-12-23:**

Ron gave an update on the meeting with BOCC. Mentioned that the ballot measure next fall will change lodging tax from 1.8 - 2.0% and then reallocate a portion to go toward childcare, affordable housing etc. Not sure of the tax range BOCC will move to new purposes. So far 2023 taxes are less than 2022. Wondering if a marketing district could be an option.

# **Dave Santucci/Marketing District**

As a tourism board and statutory county - we only have two tax options. Limited to 2% with county lodging tax.

## Dave reviewed what a marketing district is:

- Unique to Colorado like business improvement district
- Ok to generate revenue beyond 2%
- Keep tourism fully funded
- Can draw district to not include certain areas
- Lodgers need to petition BOCC
- BOCC sends to voters to approve. If approved, a new district is established to collect tax and a new board is formed.
- Other areas that have marketing districts: Alamosa, Estes Park, Gunnison, Moffat, Steamboat Springs and Vail.

Dave reviewed the benefits.

Gaylene, Ron, Kristen and Dave will get together to discuss the marketing district.
